Sir/Madam,

With reference to the above, it is to inform that as per NCTE Regulations, 2014 a revised recognition order no. WRC/323080/2015/139293 dt. 31.05.2015 was issued to the institution for conducting B.Ed. course of two year duration with an annual intake of 100 seats (two basic units of 50 students) from session 2015-2016.

The WRC in its 293rd meeting held on June 12th – 14th, 2018 considered the reply dt. 19.01.2018 and 24.08.2016 submitted by the institution, for compliance of conditions as mentioned in the revised recognition order dt. 31.05.2015 and decided as follows:-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 08.08.2016 was issued. This was followed by compliance letter dated 01.08.2017.

The institute replied on 19.01.2018.

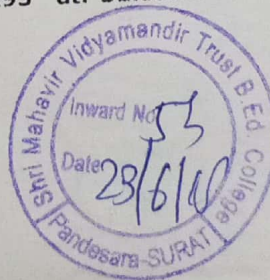
The institute has submitted an approved staff list. It has also submitted a Building Completion Certificate and FDRs for 12 Lakhs.

Hence, permitted to continue with one unit as requested by the institution."

Therefore, it is informed that the institution is permitted to continue the existing B.Ed. course of two year duration with an annual intake of 50 seats from session 2018-19.

It is also informed that the institution shall continue to follow the NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulations, 2014.

Revised Order no. WRC/323080/2015/139293 dt. 31.05.2015 be treated as cancelled from the date of issue of this order.
